



**"TOPS Markets Fresh Picks Gift Card Giveaway"
OFFICIAL RULES
July 6 – August 30, 2014**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. SPONSOR: TOPS Markets, LLC ("Sponsor") is the official sponsor of the "TOPS Today's Fresh Picks Gift Card Giveaway" ("Promotion").

2. ELIGIBILITY: Promotion is open only to legal residents of New York, Pennsylvania and Vermont, ages 18 and over ("Eligible Customers") that have a registered TOPS BonusPlus, BonusCard or Wild Card as of the start of July 6, 2014. Business entities such as corporations or companies are not eligible to enter or win. Associates, officers and directors of the Sponsor, its retail stores, distribution centers and division offices, its subsidiaries and affiliates, promotion suppliers, affiliated advertising agencies, third party contractors and spouses of the aforementioned groups (and the I.R.S. listed dependents or members of household including dependents in the military or attending college living away from home) are not eligible to win. 4. HOW TO PLAY: NO PURCHASE NECESSARY TO PLAY OR WIN. Customers with a registered TOPS BonusPlus, BonusCard or Wild Card should visit www.TopsMarkets.com and login in using their www.TopsMarkets.com account or by using their TOPS BonusPlus, BonusCard or Wild Card to play for a chance to win that day's \$100 TOPS Gift Card. Customers will click on one of three recipe images featuring fresh produce to reveal if they are that day's gift card winner; customers that are not selected as the daily winner will have the opportunity to electronically add a Click To Card coupon for in-store savings at any TOPS Friendly Market.

5. WINNER SELECTION: One winner will be selected at random on each day of the promotion. A random pre-determined and unannounced time will be selected for each day of the promotion; the next eligible individual to participate in the promotion, by selecting a fresh produce recipe image, will be that day's winner, regardless of the recipe image that they select. Winners will be notified on-screen immediately after selecting and clicking a recipe image. Chosen winner will be required to complete an online form providing their name, address, phone number and email address. The Sponsor will fulfill prize by U.S. mail within three (3) weeks of that day's promotion date. Prize may be forfeited if the U.S. mail notification is mailed and returned to the Sponsor as undeliverable mail without a forwarding address, and/or if winner(s) is unable to be contacted by telephone or e-mail. If potential winner is found to be ineligible, the Sponsor will select an alternate winner from all eligible participants for the given day's promotion. Sponsor reserves the right to substitute any listed prize for one of equal or lesser value if the designated prize should become unavailable. All prizes are non-transferable, and no substitutions will be made except at Sponsor's discretion. All federal, state and local taxes (including any sales or use tax) where applicable are the sole responsibility of the prize recipient. Total retail value of all prizes equals \$5,600.

7.
