

“Portage Road, Niagara Falls Grand Re-Opening” Sweepstakes

OFFICIAL RULES

August 9, 2026 – September 5, 2026

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

1. SPONSOR(S): Tops Markets, LLC (“Sponsor”) are the official sponsors of the “Portage Road, Niagara Falls Grand Re-Opening” Sweepstakes (“Sweepstakes”).
2. ELIGIBILITY: Sweepstakes is open only to legal residents of New York, Pennsylvania or Vermont, ages 18 and over (“Eligible Customers”). Business entities such as corporations or companies are not eligible to enter or win. Associates, officers and directors of the Sponsor and Northeast Shared Services, its retail stores, distribution centers and division offices, its subsidiaries and affiliates, franchisees, promotion suppliers, affiliated advertising agencies, third party contractors and spouses of the aforementioned groups (and the I.R.S. listed dependents or members of household including dependents in the military or attending college living away from home) are not eligible to win. This Sweepstakes is void elsewhere and where prohibited by law. Sweepstakes is subject to all applicable federal, state and local laws, rules, and regulations.
3. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00:00 a.m. on August 9, 2026 Eastern Daylight Time (EDT) and ends at 11:59:59 p.m. (EDT) on September 5, 2026 (the “Sweepstakes Period”). The Sponsor’s computer is the official timekeeping device for this Sweepstakes.
4. HOW TO ENTER: There are two ways to enter the sweepstakes. **(1) To Enter by Transaction:** Eligible Customers are automatically entered for a chance to win using their active registered Tops BonusPlus, BonusCard or Wild Card to make a qualifying purchase (“Qualifying Purchase”) at 1000 Portage Road, Niagara Falls NY Tops Friendly Markets (“Participating Store”) during the Sweepstakes Period. Customers will receive one (1) entry into the Sweepstakes for each Qualifying Transaction made at 1000 Portage Road, Niagara Falls NY Tops Friendly Markets during the Sweepstakes Period. Subject to certain exclusions listed below, a “Qualifying Transaction” is the purchase of any item by Eligible Entrants who use a registered Tops BonusPlus® at 1000 Portage Road, Niagara Falls NY Friendly Markets during the Promotion Period. Purchases that consist solely of merchandise or products prohibited by law from participating in a promotion (such as alcohol, tobacco, and/or certain milk and milk-related products in PA only), without the purchase of any other eligible merchandise or products included in the transaction and/or purchases that consist solely of gasoline and/or office services only, including but not limited to Western Union, wire transactions, money orders, postage stamps, lottery tickets, and/or utility bill transactions, without the purchase of any other eligible merchandise or products included in the transaction, shall not be considered a Qualifying Transaction. The www.topsmarkets.com website, in-store M&T Bank, Starbucks and Tim Hortons franchise locations, and stand-alone Tops Xpress or Tops Fresh Xpress locations located beyond the boundaries of a Tops Friendly Market parking lot, shall not be considered a Participating Store. A customer’s registered Tops BonusPlus, BonusCard or Wild Card must be scanned at the time of purchase for the purchase to be a Qualifying Purchase. Should multiple users of the same Tops BonusPlus, BonusCard or Wild Card enter the Sweepstakes and a dispute thereafter arise regarding the identity of the entrant, the registered card holder of said Tops BonusPlus, BonusCard or Wild Card at the time of entry will be considered the entrant. **(2) To Enter without Purchase:** To enter without purchase, Eligible Customers may enter by mail by hand printing your complete name, address, telephone number with area code and date of on a 3” x 5” card and mail it in a stamped envelope to: Tops Friendly Markets, “Portage Road, Niagara Falls Grand Re-Opening” PO Box 1027, Buffalo, NY 14240. Limit one Mail Entry per outer stamped envelope. Mail-in envelopes larger than a # 10 envelope will be automatically disqualified. Each mail entry must be separately hand written; no entry will be eligible if it was created via copier, facsimile machine or by mechanical reproduction of any kind. Sponsor is not responsible for any mail entry that is illegible, undeliverable, misdirected, mutilated, lost, late, incomplete, damaged, stolen, altered or not placed in the Entry Box. Each mail entry becomes the property of Sponsor and will not be returned. All mail entries must be postmarked by September 5, 2026 and received by the Sponsor’s Marketing Department by Monday, September 14, 2026.
5. WINNER(S) SELECTION AND NOTIFICATION: Three (3) potential winners will be selected from all eligible store and mail entries received during the sweepstakes period in a random drawing to be held by the Sponsor’s Marketing Department on or around September 15, 2026 The Sponsor, or designee, will attempt to notify the potential winners by phone on/or after the Drawing Date. The Sponsor may also choose to publish the winning Tops BonusPlus, BonusCard or Wild Card number (when applicable) on/or after the scheduled Drawing Date; announcement of the winning Tops BonusPlus, BonusCard or Wild Card number (when applicable) may be made through the Sponsor’s website, their affiliates’ websites, television, radio, and/or newspapers. Prize may be forfeited if the potential winner(s) is unable to be contacted by telephone or does not respond within three (3) days of notification. Individuals responding to an announced

winning Tops BonusPlus, BonusCard or Wild Card number or online entry must match the customer information on file with the Sponsor's Marketing Department for the given Tops BonusPlus, BonusCard or Wild Card number or online entry to be eligible to win. If a potential winner is found to be ineligible, the Sponsor will select an alternate winner from all eligible entries. Winner(s) must comply with all laws, rules and regulations concerning this Sweepstakes, as well as the Official Rules as published. Sponsor is not responsible for winner limitations that prevent acceptance or use of any prize. Winner(s) will be required to verify their identity and must sign and return an Affidavit of Eligibility, Acceptance of Official Rules, and Release of Liability/Publicity before prize will be awarded. Winner(s) will be required to return documents to the Sponsor within seven (7) days from the postmark date on the prize notification letter or email notification. 6. PRIZE(S): One (1) grand prize winner will be awarded \$1,000 in Tops Gas and Groceries Gift Cards. The approximate retail value (ARV) of this prize is \$1,000. One (1) first place prize winner will be awarded \$500 in Tops Gas and Groceries Gift Cards (ARV \$500). One (1) second place prize winner will be awarded \$250 in Tops Gas and Groceries Gift Cards. The approximate retail value (ARV \$250) Sponsor reserves the right to substitute any prize for one of equal or greater value. Total ARV for all prizes is \$1,750.00.

7. GENERAL CONDITIONS: This Sweepstakes is void where prohibited. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules and/or the rights and obligations as between any applicant and the Sponsor and any participating companies in connection with this Sweepstakes shall be governed by and construed in accordance with the internal laws of the State of New York including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws.
