

My Tops Days Sweepstakes Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.

1. Eligibility

My Tops Days Sweepstakes (the "Sweepstakes") is open only to legal residents of New York, Pennsylvania and Vermont, ages 18 and over on their date of entry into the Sweepstakes ("Eligible Entrants"). Proof of residency and age may be required. Business entities such as corporations or companies are not eligible to enter or win. Associates, officers and directors of the Sponsor and Northeast Grocery, Inc., its retail stores, distribution centers and division offices, its subsidiaries and affiliates, franchisees, promotion suppliers, affiliated advertising agencies, third party contractors and spouses of the aforementioned groups (and the I.R.S. listed dependents or members of household including dependents in the military or attending college living away from home) are not eligible to win. Void where prohibited or restricted by law. This Sweepstakes is governed by these Official Rules and is subject to all applicable federal, state and local laws, rules, and regulations. In order to enter the Sweepstakes or receive a prize, you must fully comply with the Official Rules and, by entering, you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Sweepstakes.

2. Sponsor

3. Timing

The Sweepstakes Entry Period begins on September 27, 2026, at 12:00:01 am Eastern Time ("ET") and ends on October 3, 2026, at 11:59:59 pm ET ("Sweepstakes Entry Period"). Sponsor's computer is the official timekeeping device for this Sweepstakes.

4. How to Enter

There are two (2) ways to enter the Sweepstakes:

(1) Online Entry

Eligible Entrants must visit www.topsmarkets.com/MyTopsDays and complete the online entry form by providing all required information, including name, address, telephone number, email, a valid 11- or 12-digit Tops BonusPlus®, BonusCard®, or Wild Card number and by checking the "age verification," "state verification," and "agree to the Official Rules" boxes. Upon submission, entrants will receive one (1) entry into the Sweepstakes during the Sweepstakes Entry Period. Limit one (1) online entry per person during the Sweepstakes Entry Period.

(2) Mail-In Entry (Alternate Method of Entry or "AMOE").

To enter without making a purchase, Eligible Entrants must mail a handwritten entry on a 3" x 5" card including the entrant's full name, mailing address, telephone number (with area code), and email address. The entry must be mailed in a stamped #10 envelope to: Tops Friendly Markets, "My Tops Days Sweepstakes," PO Box 1027, Buffalo, NY 14240-1027. Limit one (1) mail-in entry per outer stamped envelope. Limit one (1) mail-in entry per person during the Sweepstakes Entry Period.

Each Mail-In Entry will be processed in a manner that is consistent with each Online Entry, with each Mail-In Entry receiving one (1) Sweepstakes entry, which is equivalent to entry earned via Online. Mail-in envelopes larger than a #10 envelope will be disqualified.

Each mail-in entry must be handwritten; entries generated by photocopy, facsimile, or other mechanical reproduction are void. Sponsor is not responsible for entries that are illegible, lost, late, misdirected, damaged, incomplete, stolen, or otherwise not received. All mail-in entries become the property of the Sponsor and will not be returned. Mail-in entries must be received by the Sponsor by October 9, 2026.

All entries, regardless of method of entry, have an equal chance of winning. Limit one (1) entry, regardless of method of entry, per person during the Sweepstakes Entry Period.

5. Winner Determination

Potential winner(s) will be selected from all eligible entries in a random drawing conducted by Sponsor on or about October 12, 2026. Each entrant will be deemed a potential winner pending verification of eligibility and compliance with these Official Rules, as determined by Sponsor in its sole and absolute discretion. An entrant is not a winner of any prize unless and until eligibility and compliance with these Official Rules has been verified and the selected entrant has been notified that verification is complete. Odds of winning depend on the total number of eligible entries received.

Sponsor's decisions regarding the administration and operation of the Sweepstakes and the selection and verification of potential winners are final and binding in all matters relating to the Sweepstakes.

6. POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR. SPONSOR'S DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE WINNERS AND OTHER MATTERS RELATED TO THE SWEEPSTAKES.

7. Verification of Potential Winners

Potential winners may be required to complete and return an Affidavit of Eligibility, Release of Liability and Publicity Release (where permitted by law) (collectively, the "Affidavit") by the date specified by Sponsor. In the event: (a) potential winner cannot be reached for whatever reason after a reasonable effort has been exerted or the potential winner notification or Affidavit is returned as undeliverable; (b) potential winner declines or cannot accept, receive or use the prize for any reason; (c) of noncompliance with the above or within any of the aforesaid time periods, (d) potential winner is found to be ineligible to enter the Sweepstakes or receive the prize, (e) potential winner cannot or does not comply with the Official Rules, or (f) potential winner fails to fulfill the Affidavit-related obligations, the potential winner shall be disqualified from the Sweepstakes. Sponsor reserves the right to modify the notification and Affidavit procedures.

Fourth Winner — TOPS Coffee Pods: \$300 in TOPS Gift Cards. ARV: \$300.

Fifth Winner — TOPS Ice Cream: \$250 in TOPS Gift Cards. ARV: \$250.

The total ARV of all prizes is \$1,450.

11. General Conditions
